a. Approval of Health and Welfare Services Agreement, Middle Country CSD

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Tripi, seconded by Mr. Isernia, and carried unanimously (8-0) to approve the agreement between Sachem Central School District and Middle Country Central School District to provide health and welfare services to students who reside in the Sachem Central School District. The rate for this service is \$713.33 per student. The term of this agreement shall be from July 1, 2012 through June 30, 2013. This agreement has been reviewed and approved by the school district's attorney.

b. Approval of Agreement with Best Western Royal Plaza Hotel

Upon the recommendation of the Superintendent of Schools, a **Motion** was made by Mr. Tripi, seconded by Mr. Isernia, and carried unanimously (8-0) to approve the agreement between Sachem Central School District and Best Western Royal Plaza Hotel in Marlborough, MA. The Sachem High School East String Ensemble will arrive May 17, 2013 and depart May 19, 2013. The total cost is approximately \$2,435.00 which is being raised by the students through different fundraising events. This contract has been reviewed and approved by the school district's attorney.

Donation to Paul DiIorio
